Destined to indicate the user's presence in situation of nocturnal medium risk of low nocturnal visibility to the protection of the user body, except head, hands and feet, according to the following standard/s:

- EN ISO 13688:2013 General Requirements
- EN ISO 11612:2015 against thermal risks of limited flame spread (A1 and A2), Convective heat (B1), Radiant heat (C1) and Contact heat (F1)

Having achieved the performance requirements specified in Technical Test Report No. **2019EP0899UE** and the PPE's Technical Documentation.

Description of the PPE:

Coverall made in navy blue woven fabric with 5cm grey reflective strips, stitched. It has patch pockets with flap. Central closure has a metal zip covered by a flap and cuffs have self-fastening tape.

The materials that form the PPE, are described in the technical report nº 2019EP0899UE.

The PPE is available with the following variants:

- It can be manufactured in orange colour
- AF73: It can be manufactured in navy blue, orange, royal blue, khaki and red.
- UAF73: It can be manufactured in navy blue, khaki and royal blue.
