The device model "WORK AIR DL001 T U" is an inflatable protector with electronic activation to be used by professional workers who work at height; it is designed to protect the chest area (DC, divided chest, type A) and the central area of the back (CB) of the final user.

This device is intended to reduce the severity of injuries caused, when the user is not connected to any anchor point, impacting the ground after a minimum vertical free fall of 1.2 m, or caused, when the user is connected to a suitable anchor point, impacting obstacles when a pendulum effect is produced after a minimum vertical free fall of 1.2 m.

The activation logic of the inflatable protector of the device model "WORK AIR DL001 T U" is designed to work without physical connection with the user; it uses an electronic system placed into a plastic case: it uses an algorithm that steadily track dynamic behaviour of the user.

Two sizes provided for the inflatable bag (.1 and .2) associated to four sizes for the support system (S, M, L and XL). Relating to the protection of the back, user's waist-to-shoulder length declared for bag size .1 is (41-46)cm and for bag size .2 is (46-51)cm; relating to the protection of the chest, user's chest girth declared for size S is (80-92)cm, for size M is (92-104)cm, for size L is (104-116)cm and for size XL is (116-128)cm


