5-finger glove entirely in heat-resistant split leather mm 1.4, with internal split leather reinforcement on palm and fingers mm 1.2. Palm lined with aramid felt 120 g/sqm together with fireproof non-woven fabric 180 g/sqm. The lining on the back and gauntlet cuff is made with fireproof non-woven fabric 180 g/sqm. All stitching in Kevlar thread 50/3.
